# Bringing Technology To Vehicle Safety

Vehicle inspection flow and main elements of an inspection lane



## Smoke Emission Test

Measure the gasses that are emitted from a vehicle's engine to ensure that they are not higher than the specified legal limits. As for diesel engines, PUSPAKOM checks on the density of particles via smoke opacity tests while for petrol vehicles, the Hydrocarbon and Carbon Monoxide levels are measured



## Identification Check

Verify the identity of a vehicle by checking the chassis and engine numbers against its documentation



## Headlight Test

Measure a vehicle's light beam condition



## Above-Carriage Check

Examine the upper body of a vehicle to check for defects in accordance with the Road Transport Act 1987



## Tinted Glass Test

Measure the visible light transmittance rating of windscreens and windows in accordance with regulatory requirements

Test the alignment of the tyres and road handling effectiveness during lateral movement



#### Speedometer

Check the accuracy of the speedometer against the speed of the wheels

Check on a brakes' efficiency and brake imbalance, run-out and residual force as well as in parking mode



#### Suspension Test

Test the suspension system, including performance of springs, shock absorbers and joints on each axle

## Why Vehicles Need Regular Inspection



### Safety

Your vehicle should be inspected advisably twice a year to identify any defects that may potentially compromise its roadworthiness



### Environment Conservation

In getting your vehicle checked, you would be doing your part in preserving the environment as inspection will ensure that your vehicle does not excessively emit black smoke and harmful gasses that pollute our environment

Inspections can help detect potential mechanical defects and faults in your vehicle before they become more serious and costly to repair

## Types Of Inspection

PUSPAKOM's network of inspection centres is well-equipped with comprehensive inspection facilities to inspect heavy or light commercial and private vehicles. Our range of inspection services are also tailored to individual needs and specific requirements. The types of inspection we provide are:

### Initial Inspection

New or used commercial vehicles pending a transfer of ownership are required to undergo initial inspection prior to registration with the Road Transport Department to ensure they comply with regulatory standards in relation to their construction and use

### Routine Inspection

Periodic mandatory inspection of commercial vehicles, with a focus on their legality and roadworthiness as required under the Road Transport Act 1987

### Special Inspection

Mandatory inspection of private vehicles with road tax that have expired for more than three years and all commercial and private vehicles that have had the specifications of their engine, chassis, components or body changed, interchange of car registration number, new or used imported vehicles to be registered with the Road Transport Department, as well as other types of inspection required by the Road Transport Department to ensure compliance with road safety regulations

### Transfer of Ownership Inspection

Prior to transfer of ownership and the necessary formalities at the Road Transport Department, all private vehicles must undergo this inspection

### Hire Purchase Inspection

Any buyer (individual or organisation) applying for a loan to purchase a used vehicle is required, under the Hire Purchase Act 1967, to send the vehicle for a Hire Purchase Inspection at PUSPAKOM. This inspection helps to protect buyers of used vehicle from buying an illegal or unroadworthy vehicle

### Voluntary Vehicle Inspection

Besides mandatory inspection, Voluntary Vehicle Inspection helps private vehicle owners who do not compromise on vehicle safety to ensure that their vehicles are roadworthy. Voluntary Vehicle Inspection is also preferred by car dealers and vehicle auction house to help ensuring the safety condition of vehicles in the process of purchase and sale of used cars
